- 1- Ministry of Trade/ General Company for Grain Processing has the pleasure to announce for the first time a tender of supplying Premix with quantity (777 Tons).
- 2- General Company for Grain Processing has financial allocation from (ration card allocation) with estimation cost (3250 \$) three thousand two hundred and fifty dollar per ton .
- 3- Who would like to buy tender documents (Arabic/ English languages); should submit written request to GCGP / Legal department (in Baghdad /Aden Sq./ Entrance of Hurriya City) against amount of (1,000,000 ID) One million Iraqi dinars as a (approved check) non - returnable, from one of the governmental banks or (TBI) or any Iraqi bank in Baghdad depended by Central Bank of Iraq in a "good degree and above.
- 4- Tenders should be submitted in closed and stamped envelope written on it(name and number of the tender) to be placed in Box of Tenders in the office of General Director in GCGP , last date for receiving tenders will be at (10:00) A.M Monday 10/ 7/2017 Baghdad local time. Opening the tenders will be in the same date . The prices of offers shall be final not negotiable, any tender does not fulfill the conditions above will be dismissed and GCGP is not obliged to accept the lower prices. Tenders will open in presence of bidders or their representatives who want to present at the same time, date and address (Late tenders will be neglected).
- 5-The Company who win the tender will bear the fees of publishing announcement and any other charges and will bear the legal responsibility about submitting any forged documents and the legal procedures will be taken against the company. The bidder should determine bid validity for a period not less than four months from closing date.

Required Documents:

- 1- Establishment Certificate of the bidder company with clearance of renewing taxes, legalized from the companies registration office in Ministry of Trade and if it is established outside the country, it should be legalized by the Iraqi embassy or consulate or attaché in the country of establishment.
- 2- Representative of foreign company, if any, has to present official authorization signed and stamped by company's stamp and officially legalized by the Iraqi Embassy in Seller country. If the company has a Bureau in Iraq should submit its registration according to Iraqi law.
- 3-in case of submitting copied documents; it should be legalized and stamped from the issuing side, while the identification documents (id, certificate of nationality, residential card, etc).
- 4-Bid Bond must be submitted as approved check or Bid Bond in ratio of 3 % of the estimate cost, issued by one of the governmental banks or (TBI) or any Iraqi bank in Baghdad depended by Central Bank of Iraq a good degree and above, in favor of GCGP by the bidder only or his legal representative (its expiry SIX months).
- 5-Bidder should submit a book of non-objection from participation in tender issued by General Commission of Taxes for the year 2017, addressed to GCGP exclusively (bidder should submit clearance from the same commission after assignment).
- 6- Purchase bill of tender documents (original).
- 7-Bidder should submit any document that confirms similar works in the field of additives.
- 8-A conference for replying inquiries of bidders will be held at (10:00) A.M Sunday 9/ 7 / 2017 Baghdad local time in the head quarter of GCGP/Meetings hall.
